Straw poll taken to determine the number of RCMs/Areas who are interested and/or committed to relocating to the Windham ~ only one RCM did not want to move & remainder believes we should.

RCM noted the RD/RCM workshop on yesterday only had 3 RCMs in attendance ~ feels that his informational workshop should be well attended since the RCMs are the final decision makers at this service body. This is one of the most effective means for an exchange of information at the regional level & the service structure.

RCM started discussion of possibly having GRCNA (our Convention) to be in one central location every year instead of moving around to different venues ~ this has come to the Region previously over the last several years and it has not/did not come to consensus from the Areas at those times.

RCM expressed concerns regarding continuity of service in his Area and others ~ how can we inform newcomers of membership and how to be of service in NA's fellowship.


